1.	for the proceeding related to the resumption of study	100 EUR	payable on the day of filing the application ³
2.	for the proceeding related to the transfer from another university	100 EUR	payable on the day of filing the application ³
CHARGES FOR TUITION IN THE REGULARLY SCHEDULED TIME OF STUDY (TUITION FEE)			
3.	for the total study period	7000 EUR	payable before the beginning of the first classes in the first year of the programme
4.	for the academic year	3550 EUR	payable before the beginning of the first classes in the first year of the programme
5.	for one semester (one-time payment)	1800 EUR	payable before the beginning of the first classes in the given semester of the programme
6.	for one semester (payment in installments, 5 installments in a semester)	1900 EUR (one installment 380 EUR)	The first installment payable before the beginning of the first classes in the given semester of the programme, next installments – payable by the last day of each following month at the latest
CHARGES FOR THE ASSESSMENT OF ACHIEVEMENTS IN OTHER UNIVERSITIES			
7.	for the analysis of an application for recognising a grade scored in another higher education institution	20 EUR per course	payable on the day of filing the application ³
CHARGES FOR THE REPEATED COURSES AND EXTRACURRICULAR COURSES			
8.	for repeating failed courses and for ECTS surplus (over 6 ECTS points) resulting from covering extracurricular courses during the whole study period	60 EUR for 1 ECTS point	payable within 14 days of the Dean's decision – for the whole class period or in installments on the dates set by the Dean

NOTE. A student studying the first field of second cycle studies at SGH shall pay the tuition fee for the second and next field of study in the second cycle programme run as a part-time programme in Polish or a full-time programme in English pursued simultaneously at SGH at the amount of 80% of the fee stipulated in the above table.

¹ Payments shall be effected in euros to the appropriate individual Student account indicated in the Virtual Dean's Office system run under the University's bank account.

² Fees should be paid in each of the fields of study pursued.

³ The proceeding requires filing an application. Should the application be filed without effecting the payment, the applicant shall be requested to make the payment in the specified time. After the lapse of the specified time the application shall not be considered.
